Dulin retirement meeting set The Northampton County Retirement System board of trustees is hoping to settle the state's concerns over a proposed change to its health care benefit plans, according to a staff report. The state of Pennsylvania is asking the retirement system, which provides health care benefits for 165,000 county workers, to shift from its current plan to one that is less expensive and more aligned with the Affordable Care Act. The retirement system is expected to consider the proposal at its Dec. 11-12 meeting in Northampton. The meeting will be held at the retirement system office, 2000 County Administration Center, 300 County Administration Center Drive, Easton. It's unclear when or how the proposal was developed. "The board of trustees has worked diligently to respond to the concerns raised by the state," said Bob Obrecht, chairman of the county retirement system board, in a statement. "We look forward to continued meetings with the state to discuss their proposal and to hear our input on how we best protect the retirement system's most important asset - our current and future employees." Glucagon-like peptide-1 (GLP-1) is a key incretin that promotes glucose-dependent insulin secretion and suppresses glucagon secretion, so it has a potent glucose lowering effect when administered alone or in combination with insulin. However, the half-life of GLP-1 is relatively short, so multiple daily injections are required to achieve 24 hour plasma exposure. A GLP-1 mimetic with longer duration of effect would be an important addition to the armamentarium of treatments for diabetes. We propose to develop more potent and longer-acting GLP-1 agonists that act through alternative G protein-coupled receptors, which we believe will be

This invention relates to a machine for attaching tags to items such as garments, and more particularly to a machine for attaching tags to garments so that the owner of the garment can display the tag together with other information about the garment such as the size, brand, etc., on the reverse side of the tag. A number of machines have been developed for the attachment of tags to garments or items of clothing. In many of these machines, the tag is applied to the garment or item of clothing, by moving the garment or item of clothing across the tag attaching machine such that the tag is inserted between a pair of jaws on the machine and then the tag is moved past a stationary operator so that the tag is temporarily secured to the garment or item of clothing by means of a clip. The machine continues to move the garment or item of clothing across the tag attaching machine to permit the tag to remain on the garment or item of clothing while additional tags of the same type as the original tag are attached to the garment or item of clothing. Thus, the machine not only performs the tag attaching function, but also conveys the garment or item of clothing across the tag attaching machine. Some machines such as disclosed in U.S. Pat. Nos. 3,676,038, 4,022,314 and 4,307,766 have provided for the removal of the tag from the garment after it has been initially attached to the garment so that the garment can be reused. These types of machines, however, require the use of pins inserted into the tag so that the pins remain in the tag after it is removed from the garment. This type of pin and pin hole arrangement requires the inclusion of the pin in the tag and therefore becomes a permanent part of the tag. U.S. Pat. No. 4,715,621 discloses a machine for attaching tags to garments wherein the tag is detached from
